LLCU SHARE YOUR STORY CONTEST



CONTEST RULES & RESTRICTIONS

- 1. **Eligibility:** The LLCU "SHARE YOUR STORY CONTEST" is open to anyone who: (i) follows these rules; (ii) is a legal U.S. resident and (iii) is 18 years of age or over as of December 9th 2024. Officers, directors, and employees of LLCU are not eligible to win the prize but immediate family members (spouse, parent, child, sibling) and persons residing in their households are eligible to enter the contest. The contest is void where prohibited by law. The contest is subject to all applicable federal, state, and local laws and regulations. By participating in the contest, you agree to the terms and conditions of these Official Rules. The prize is subject to availability and may be subject to change without prior notice with an item of equal or greater value.
